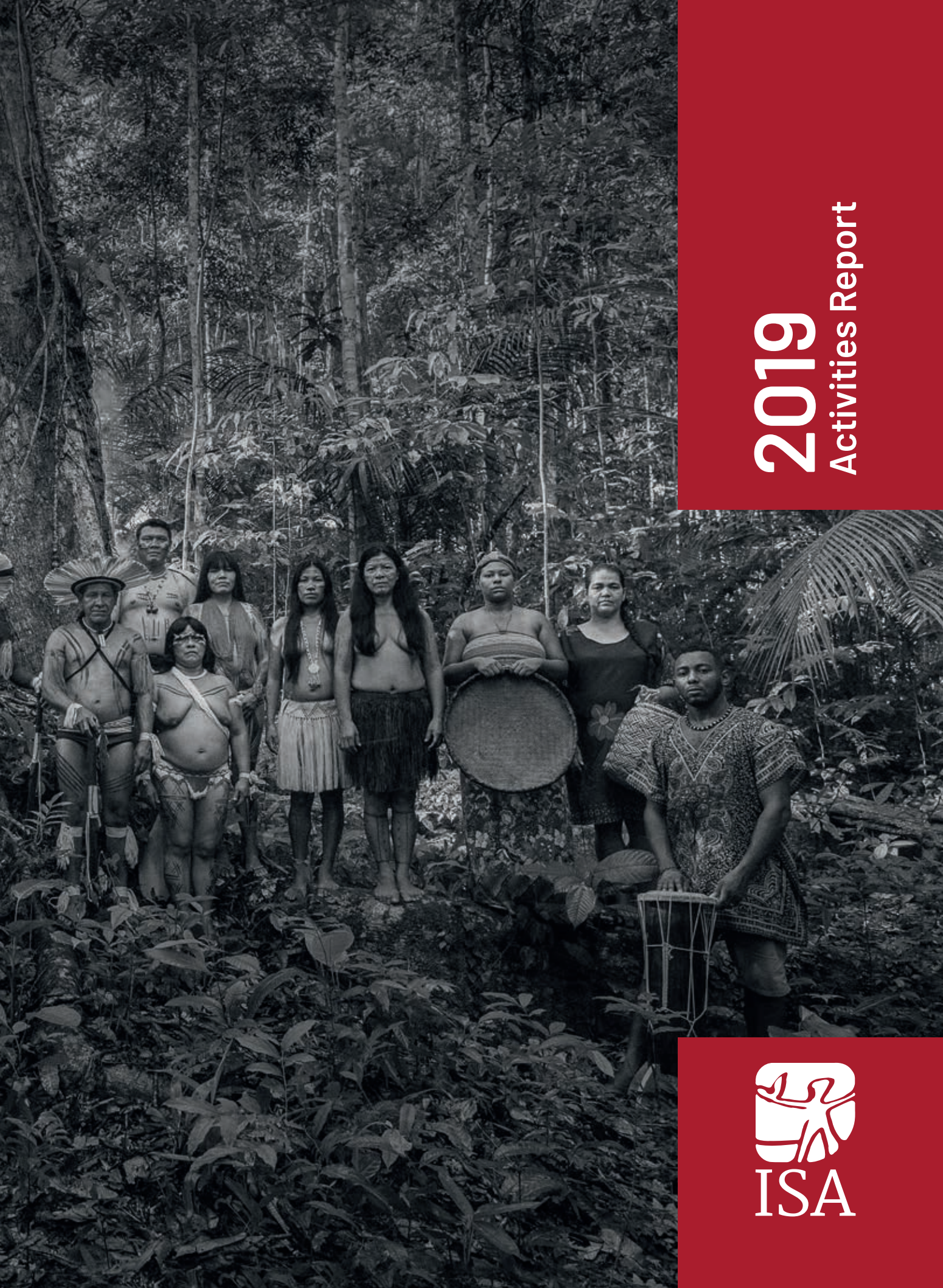

A social and environmental pandemonium. The expression summarizes what the year of 2019, the first of the Jair Bolsonaro administration, was. What was seen was stimulation for deforestation and land grabbing, criminalization of NGOs, and dismantling of agencies for the environment and the defense of the rights of indigenous and traditional populations. It was a succession of attacks and of disrespect. The outburst of fires in the Amazon, the break up with the Amazon Fund – which funded, with resources from international cooperation, the fight against deforestation –, and the president's statements encouraging mining and the economic exploitation of Indigenous Lands, among other things, caused astonishment and made headlines in the national and international media.

If, on the one hand, the government promoted almost daily setbacks, on the other civil society organizations articulated in defense of socio-environmental policies and indigenous and traditional peoples' rights. ISA took a stand throughout the year against these setbacks in editorials and signed articles in newspapers and websites, producing news and mobilizing society. Meanwhile, its field teams continued to carry out and intensify activities to further strengthen the role of forest peoples, giving them voice and support. Good examples are the monitoring of deforestation in the Xingu River Basin, in the States of Pará and Mato Grosso, carried out by Xingu + Network (Rede Xingu +), exposing logging invasions; the analyzes of protected areas in the Amazon, with the assessment of their management and the threats to them; and the monitoring of the gold mining invasion of the Yanomami Indigenous Land, in Amazonas and Roraima – the theme of the *Fora Garimpo* (Mining Out) campaign, promoted by the Hutukara Associação Yanomami with ISA's support.

Isolated Indians, and their vulnerability, were closely monitored. This resulted in the book *Cercos e Resistências: Povos Indígenas Isolados na Amazônia* (Sieges and Resistances: Isolated Indigenous Peoples in the Amazon), a portrait of these peoples. Dossiers on their situation were also prepared and presented at international forums.

In Brazil's National Congress, ISA monitored bills, Provisional Measures and the Proposed Constitutional Amendment opening Indigenous Lands to economic exploitation. The Socio-

Environmental Policies & Law Program team participated in public hearings and meetings with the Federal Prosecution Office and prepared legal opinions and technical notes. The highlight was its actions in the Parliamentary Environmentalist Front Task Force, with participation in meetings to debate changes in the bill that eases environmental licensing.

In the midst of this chaotic political scenario, ISA celebrated its 25 years with a Film Exhibition in São Paulo, events, debates and the message *Vamos Continuar Resistindo* (We Shall Resist), theme of a campaign launched during the celebrations that highlights the disposition of the forest peoples to defend their rights.

The 23 indigenous peoples of the Negro River Basin, in the Amazon's northwest, and the Yanomami and Ye'kwana, from the Yanomami Indigenous Land, published their Environmental and Territorial Management Plans (PGTAs, in the Portuguese acronym), after years of hard work and joint construction. The peoples of the Negro River also started to build their Consultation Protocol. The Yanomami, the Ye'kwana, the Xingu and the Panará peoples, in turn, finalized their protocols, with rules to be respected in the face of developments that may impact their territories, and handed them over to the federal government. Other important achievements in the development and enhancement of forest products, involving indigenous, extractivist and *quilombola* (descendants of runaway slaves) communities are noteworthy. Such is the case of the babassu flour from the extractive reserves of Terra do Meio, in Pará, which was added to the school lunch in the municipality of Vitória do Xingu; the *pequi* oil (*pequi* is a fruit found in Central Brazil) produced by the Kisêdjê people of the Wawi Indigenous Land, in Mato Grosso, who won the UN Equator Prize; the corn harvest in the Quilombo São Pedro (*quilombos* are communities of descendants of runaway slaves), in the Ribeira River Valley, in São Paulo, which strengthened the traditional *quilombola* agricultural system; the festival that celebrated the Yarang, Ikpeng indigenous women gatherers who are part of the Xingu Seed Network; and the forest products festival in São Paulo.

**ISA's activities are carried out through programs, projects and services, which are articulated at different levels – regional, national and international.**

The **Monitoring Protected Areas and Indigenous Peoples in Brazil** area has its origins in the Centro Ecumênico de Documentação e Informação (Ecumenical Documentation and Information Center, Cedi), the organization that gave rise to the Instituto Socioambiental. Two teams – Monitoring and Indigenous Peoples – base their work on the provision and selection of free access data and qualified analyses, contributing to the defense of social, collective and diffuse rights related to the environment, cultural heritage and human and indigenous, *quilombola* and traditional rights. And, thus, oppose discourses of hate, prejudice and with no technical basis, influencing politically the construction of fair, sustainable socio-environmental scenarios. In addition to books, maps, technical notes and specific community partnerships, the program is dedicated to the maintenance and daily update of award-winning web portals on Conservation Units and Indigenous Lands and their peoples, with both national and international repercussion and recognition and accesses all over the world.

**Amazon Network of Georeferenced Social and Environmental Information, Raisg (Rede Amazônica de Informação Socioambiental Georreferenciada)** is a regional initiative that generates georeferenced data and gives visibility to the socio-environmental situation of Pan-Amazon. Coordinated by ISA, it promotes data exchange and circulation produced by eight civil society institutions from six Amazonian countries: FAN (Bolivia); Imazon and ISA (Brazil); Gaia (Colombia); EcoCiencia (Ecuador); IBC (Peru); Provita and Wataniba (Venezuela).

**The Socio-environmental Law & Policy** area seeks to guarantee the implementation of rights related to the environment and to indigenous peoples and traditional populations through a monitoring, intervening agenda that seeks to influence public socio-environmental policies in Brazil's Executive, Legislative and Judiciary branches.

The **Communications** area is responsible for the political coverage of projects and for ISA's institutional communication through websites, press relations, social networks, audiovisual productions and content dissemination. It also promotes engagement and relationship actions.

The **Services** department encompasses the areas of **Administration, Computing, Geoservices, Institutional Development and Documentation**.

The **Administration** area is responsible for ISA's administrative, financial and human resources management, contracts, and compliance with tax, accounting and labor laws, among other activities.

The **Computing** area is in charge of the routines for the operational maintenance and the support of ISA's servers and workstations in conditions suitable to the needs of the work teams. Its main focus is the availability of services 24 hours a day, acting preventively in its internal cloud structure and ensuring the continuity of activities through backups on disks and tapes. It offers remote support for workstations through online tools and/or videoconference.



**Geoservices** is the area that produces, updates and disseminates cartographic data and develops Geographic Information Systems (GIS), basically elaborating socio-environmental diagnostics of Indigenous Lands and Conservation Units.

The **Institutional Development** area aims to improve the capacity of the flow of internal and external data through systems of gathering, processing and management of updated, appropriate information related to contractual commitments and obligations. It also aims to facilitate the permanent entry of resources through support for project designs, negotiation with financing institutions and production of reports.

The area of **Documentation** is responsible for ISA's audiovisual and bibliographic collection, archival materials and news from newspapers about indigenous peoples, traditional populations and the environment. It was created in 1974.

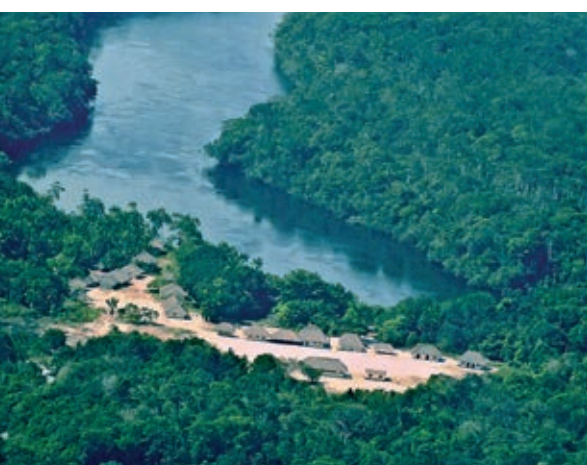

## Ribeira River Valley

This program covers the Ribeira de Iguape River Basin and the Lagoon Estuarine Complex of Iguape-Cananéia-Paranaguá, located in the southeast part of the State of São Paulo and northern coast of the State of Paraná. It aims to contribute to the construction of a regional development model based on the socio-environmental wealth of the Atlantic Forest. In partnership with the local *quilombos* (villages of descendants of runaway slaves) cooperative, *quilombola* associations, city halls and civil society organizations, it proposes and implements projects for environmental territorial planning and management and for income generation based on the enhancement of forest and agricultural product chains from *quilombola* territories.

## Negro River

This program aims at the welfare and sustainability in the Negro River Basin, in the Amazon's northwest, encompassing parts of the States of Amazonas and Roraima. It promotes processes and articulates multiple partnerships to strengthen socio-environmental diversity and encourage collaborative production (intercultural and interdisciplinary) of knowledge. The region has more than 80 million hectares. The Negro River Basin itself has 71 million hectares and includes the Branco River, its largest tributary of clear waters. The Negro River Basin has 40 indigenous peoples and 91 indigenous territories officially recognized and 13 still not recognized, 81 Conservation Units for indirect use and 14 for direct use. The program is divided into two subprograms: Negro River, in Amazonas, covering indigenous territories in the municipalities of

São Gabriel da Cachoeira, Santa Isabel do Rio Negro and Barcelos; and Branco River, in Roraima, focused on the Yanomami, Raposa Serra do Sol, Waiwai and Tabalascada Indigenous Lands. The work is carried out in partnership with the Federação das Organizações Indígenas do Rio Negro (Federation of Indigenous Organizations of Rio Negro, Foirn), the Hutukara Associação Yanomami (Hutukara Yanomami Association) and the Conselho Indígena de Roraima (Indigenous Council of Roraima, CIR), among other local indigenous organizations, civil society and research institutions.

## Xingu

The program operates in the Xingu River Basin, in the States of Mato Grosso and Pará, in partnership with local organizations of indigenous peoples, riverside dwellers and family farmers. The focus is to contribute to the consolidation of the Corredor de Áreas Protegidas (Protected Areas Corridor), a set of Indigenous Lands and Conservation Units of 26 million hectares along the Xingu River. The program articulates partnerships and promotes intersectoral dialogues for the development of projects in the Xingu Basin, with a strategic focus on four themes: protection of territorial rights; forest economy; strengthening of local partners; and climate emergency. Highlights include the monitoring of pressures and political incidence in the context of the Observatório De Olho no Xingu (An Eye on the Xingu Observatory); commercial arrangements for forest products under the Rede de Cantinas da Terra do Meio (Terra do Meio *Cantinas* Network – *cantinas* being warehouses + community centers) and the Xingu Seeds Network (Rede de Sementes do Xingu); the Xingu + Network (Rede Xingu+), a political articulation of indigenous, riverside dwellers and civil society organizations operating in the Xingu Basin; and innovative works of adaptation and fire fighting carried out in the Xingu Indigenous Territory.

## Strategic objectives and main actions





# 1 Strengthen the diversity of indigenous peoples, *quilombolas* and traditional peoples with their knowledge and ways of life

## Xingu

- Support for 35 projects in the Xingu Indigenous Territory (TIX, in the Portuguese acronym) through the Apoio a Iniciativas Comunitárias (Support for Community Initiatives, AIC), a partnership between ISA, Associação Terra Indígena Xingu (Xingu Indigenous Land Association, Atix) and Fundação Nacional do Índio (Indian National Foundation, Funai).
- **Conduction of a new research cycle in Terra do Meio, with the contribution of traditional peoples to combat the climate crisis and the loss of biodiversity, with 27 local researchers in five research topics.**



- Support for independent monitoring by the Juruna people (Yudja) of Volta Grande do Xingu (Pará) on fishing and impacts of the Belo Monte Hydroelectric Plant in their territory. Support for the inspection carried out by the Federal Prosecution Office in the region and for a seminar in Belém (Pará) and in the Attorney General's Office, in Brasília, with the Rede de Pesquisadores da Volta Grande do Xingu (Volta Grande do Xingu Researchers Network).

- Promotion of the 16<sup>th</sup> General Meeting and 5<sup>th</sup> Assembly of the Associação Rede de Sementes do Xingu (Xingu Seed Network Association), in São Félix do Araguaia (Mato Grosso).
- Third year of operation of the TIX Governance Structure.
- Support for research by the Conselho Ribeirinho (Riverside Council), of Altamira (Pará), to identify priority areas for the resettlement of families impacted by the Belo Monte reservoir.

## Socio-environmental Policy & Law

- Follow-up of the procedural progress of 302 lawsuits in different instances of the Judiciary, with direct action in 12 of them – as plaintiff or as *amicus curiae*.
- Monitoring of 1,379 legislative and political proposals – bills, petitions, proposals for Constitutional Amendments, among other legislation that impact indigenous and socio-environmental rights –, of which approximately 120 are in active process. The program participated in several public hearings and assisted congressmen, parliamentary fronts and technical committees of the Chamber of Deputies and the Federal Senate in formulating proposals to guarantee rights and prevent setbacks.
- Participation in various mobilizations and denunciation actions against threats to socio-environmental rights in specific areas of the federal government, with emphasis on efforts to revoke the Federal Attorney

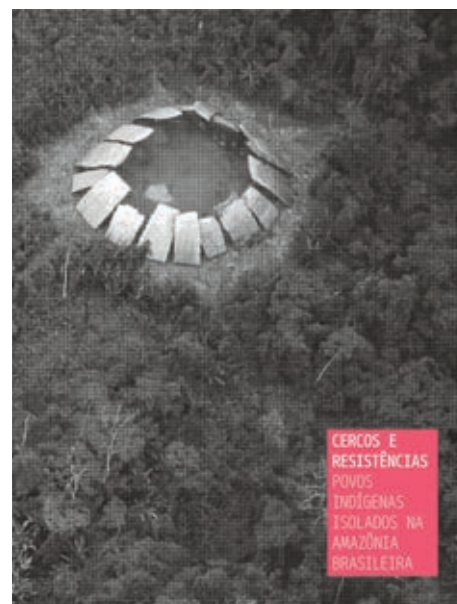


General's Office (Advocacia Geral da União)'s Legal Recommendation 001/2017, which changed the administrative procedures for the demarcation of Indigenous Lands, subordinating them to restrictions not provided for in the Constitution, such as the physical presence of the Indians in their land in October of 1988 (date of promulgation of the Constitution). Denunciation and pressure on the government to revoke the ordinance that changed the demarcation procedures for Indigenous Lands by creating, within the Ministry of Justice, a Specialized Technical Group to assist the minister in decisions involving demarcations.

- Actions in the Supreme Court, in conjunction with the Federal Prosecution Office and other civil organizations, have resulted in positive precedents for the recognition of the rights of indigenous peoples, *quilombolas* and traditional communities, as well as for the protection of forests and biodiversity both in private and protected areas, especially in the theme of the Temporal Framework. ISA was *amicus curiae* in the Extraordinary Appeal with General Repercussion recognized by the Supreme Court to determine the interpretation of the articles that define indigenous rights in the Brazilian Constitution. Defense of the rights of the Guarani of the Morro dos Cavalos Indigenous Land, in Santa Catarina, in the Supreme Court. Elaboration of appeals and delivery of memorials to the Supreme Court in the *quilombola* Direct Action of Unconstitutionality (ADI, in the Portuguese acronym).

#### Monitoring of Protected Areas and Indigenous Peoples

- Support for the production of the documentary *Ka'azar Ukize Wà – Os Donos da Floresta em Perigo* (Ka'azar Ukize Wà – The Owners of the Forest in Danger), an alert and a cry for help from the Guajajara people, who directed the film, for the protection of the forests and their isolated relatives, the Awá Guajá, with whom they share the Araribóia Indigenous Land, in Maranhão. ISA also supported a film editing workshop with Mari Corrêa, of the Instituto Catitu, and the finalization of the documentary. It got the award of best film in the environmental film exhibition at the 26<sup>th</sup> Vitória Film Festival.



- The book *Cercos e Resistências: Povos Indígenas Isolados na Amazônia* (Sieges and Resistances: Isolated Indigenous Peoples in the Amazon) provides a picture of indigenous peoples in isolation in the Amazon. It has an overview of isolated peoples, under a number of pressures and threats, and articles on the main records of isolated indigenous peoples in Brazil: Yanomami Indigenous Land and the Moxi Hatëtëa Thëripë; Awá Guajá, in the Indigenous Lands of Maranhão; isolated Kawahiva peoples in southern Amazonas; isolated peoples in Acre and in the Kawahiva Indigenous Lands of the Pardo River, in the Javari River Valley;

**Uru-Eu-Wau-Wau, in Rondônia; and Pirititi, in Roraima. The articles involved 62 experts and indigenous representatives.**

### Ribeira River Valley

- Evaluation of the #TáNaHortaDaRoça (#It'sFarmingTime) campaign with *quilombola* associations as part of the actions to safeguard the Quilombola Traditional Agricultural System (SATQ).
- Elaboration of a proposal that resulted in the Rodrigo de Mello Award, granted by the National Historical and Artistic Heritage Institute (Iphan, in the Portuguese acronym), for the *quilombos* seed fair.
- Production of the children's book *Roça é Vida* (Roça Is Life), on traditional planting fields, by the *quilombola* education group.
- **Participation in the corn harvest *puxirão* (big push) in Quilombo São Pedro, in celebration of the recognition of SATQ as a Brazilian cultural heritage.**



- Participation in the seminar *Patrimônio Agroalimentar: Promovendo Saberes e Práticas* (Agri-food Heritage: Promoting Knowledge and Practices), organized by Iphan.



- **Support for the implementation of a weekly market for organic products of *quilombola* communities, carried out in partnership with Cooperquivale, with the participation of 11 communities.**
- 12<sup>th</sup> Fair for the Exchange of Seeds and Seedlings of *Quilombola* Communities in the Ribeira River Valley (Feira de Troca de Sementes e Mudanças das Comunidades Quilombolas do Vale do Ribeira), carried out in partnership with local *quilombola* associations, preceded by the seminar Traditional Seeds and Food Sovereignty.
- Support for the elaboration and implementation of projects related to the National School Feeding Program (Pnae, in the Portuguese acronym) and the Food Acquisition Program (PAA) and access to new markets. The team followed the implementation of five contracts by Cooperquivale (Cooperativa dos Agricultores Quilombolas do Vale do Ribeira, or Quilombolas Farmers' Cooperative in the Ribeira River Valley) and Pnae and one contract with PAA, in addition to sales to the Pinheiros Municipal Market, in São Paulo. Organic products also began

to be sold to Instituto Feira Livre and Instituto Chão, fair trade venues in São Paulo.

- Support for the food processing structure in *quilombola* territories, namely: 1) Quilombo Nhunguara's banana chip factory has undergone an adjustment in water supply and sanitation; training in good manufacturing practices was carried out, the internal regulations of the factory were agreed upon and the unit's licensing protocol was initiated. 2) At the manioc flour house in Quilombo Porto Velho, a survey of documentation and adjustments to the physical structure and processing organization chart was carried out; a consultancy term of reference was published in order to adapt the processing unit. 3) In the honey processing house in Quilombo Porto Velho, the focus was on the administrative/accounting arrangement. 4) At Quilombo Sapatu's banana derivatives plant, the focus was on a new arrangement for the plant's licensing.
- Support for communities to participate in seed exchange fairs in the State of Paraná municipalities of Castro and Lapa.

### Negro River

- Support for the Waiwai, of Roraima, in structuring their Brazil nut production chain, part of the food culture of this indigenous people. The Brazil nut chain is the engine of life transformation and helps the surveillance of their territory, threatened by invaders.
- Construction of Brazil nut storage infrastructure in the Waiwai, in Roraima and the Trombetas Mapuera, in Roraima, Amazonas and Pará, Indigenous Lands.



- **Support for the launch of the book *Përisi*, produced by the Associação de Mulheres Yanomami Kumirâyōma (Yanomami Kumirâyōma Women's Association). In it, Yanomami women present a new species of fungus that they use in basketry braided with vines that they produce. The publication is the result of intercultural research and brings together the power of science and traditional indigenous knowledge, in addition to broadening perspectives and helping to strengthen the Yanomami culture.**
- The Conselho da Roça (Roça Council) – *roça* meaning planting field – met in São Gabriel da Cachoeira (Amazonas) with ISA's support to plan actions to enhance and generate income with products of indigenous agriculture in the region and the maintenance of the Traditional Agricultural System of Rio Negro (SAT RN, in the Portuguese acronym). The group, comprised exclusively of farmers and other indigenous leaders from the Negro River, debated the next steps for their strengthening.



- **1<sup>st</sup> Wariró Art Meeting, held in São Gabriel da Cachoeira (Amazonas), valuing the productive chain of handicrafts, part of the culture of the 23 indigenous peoples of the Negro River. In addition to being a shop for indigenous crafts, Casa Wariró has become a point of reference for indigenous craftsmen and a center for the dissemination of knowledge and tradition.**
- The project *Diversidade Linguística na Terra Indígena Yanomami* (Linguistic Diversity in the Yanomami Indigenous Land), a partnership of the Hutukara Associação Yanomami and ISA, released in 2019 – the International Year of Indigenous Languages –, the result of a survey on the Yanomami languages, identified a sixth language: Yãnoma. This resulted in the publication *As Línguas Yanomami no Brasil: Diversidade e Vitalidade* (The Yanomami Languages in Brazil: Diversity and Vitality). It has a historical and sociolinguistic panorama of the groups that speak these languages and points out their grammatical similarities and differences. The project also assessed the health of those languages, identifying the main threats to them.

- The annual Tiquié cycle was projected on the facade of the Humboldt Forum's new building in Berlin, Germany, during the celebrations of Alexander von Humboldt's 250<sup>th</sup> birthday.
- The Protocol of Consultation of the indigenous peoples of the Serra da Lua region, in Roraima, was finalized. It was elaborated by the Indigenous Council of Roraima (CIR) with ISA's support. The Serra da Lua region will be one of the most impacted if the Bem Querer hydroelectric plant, on the Branco River, is built.

## 2 Strengthen the political role of traditional peoples, indigenous peoples and *quilombolas*

### Xingu

- **Three training workshops were conducted with leaders from the Xingu Indigenous Territory (TIX) to use a monitoring tool (called ODK) to collect data on deforestation, invasions, mining, and places of importance for indigenous people in TIX such as archaeological sites. The highlight was the first training of indigenous women in the use of ODK.**
- Fourth meeting of the Xingu+ Network, in the Kayapó's Menkragnoti Indigenous Land, in Pará.
- Continued assistance to the Xingu Indigenous Land Association (Atix) and the Tulukai, Tapawia, Kisêdjê (AIK), Moygu and Iakiô indigenous associations in the political dialogue with their communities, regions and partner institutions.
- Legal and management advice on the sale of socio-biodiversity products to Atix, Tapawia, AIK and Tulukai.
- 6<sup>th</sup> Terra do Meio Extraction Week, in Altamira (Pará).
- Technical and legal advice for the consolidation of the Terra do Meio *Cantinas* and Mini-Plants Network – *cantinas* are warehouses + community centers –, formed by 13 associations of indigenous peoples, riverside dwellers and small farmers for the sale of forest products.
- Technical and legal advice to Terra do Meio's extractivist associations Xingu Riverside Council and Associação Yudjá Miratu da Volta Grande do Xingu (Aymix).
- Creation of the trademark Vem do Xingu (It Comes from Xingu), to identify all products of the Terra do Meio *Cantinas* and Mini-Plants Network.



- **Legal and technical advice by the Xingu + Network in the preparation and implementation of consultation and consent protocols for the Panará people and the Kayapó Menkragnoti associated with the Kabu Institute.**

- Installation, in partnership with Terra do Meio associations and the Brazilian Digital Radio Association, of infrastructure for transmission of digital data in short waves in the Extractive Reserves.
- Completion of the 4-year training cycle for managers of the Xingu Seed Network Association, which included indigenous people, family farmers and urban residents, in a training facilitated by the Instituto EcoSocial.
- Support for the Amazônia Centro do Mundo (Amazon Center of the World) meeting, in which indigenous people, riverside dwellers, young European climate activists and scientists gathered at the Rio Iriri Extractive Reserve, in Terra do Meio, for immersion and to form alliances to reflect about current issues and the future of the Amazon.
- **Support for the celebration of the 20<sup>th</sup> anniversary of the resumption of the Wawi Indigenous Land, in Mato Grosso.**
- Two modules of the training workshop in associativism and project management of the Apoio a Iniciativas Comunitárias (Support to Community Initiatives, AIC) were carried out, with 52 participants from 24 different villages.
- Protagonism of Indians in the training and management actions of the Xingu Seed Network Association.
- Assistance for the Terra do Meio extractive associations to access public policies to guarantee minimum prices, sale and financing of socio-biodiversity products, in addition to institutional markets.
- Support for the 5<sup>th</sup> Meeting of Terra do Meio *cantineiros* (keepers of *cantinas*, warehouses + community centers).
- Participation in the Cerrado Peoples Meeting and Fair – *Cerrado* being the savannas of Central Brazil –, in Brasília, in workshops of the National Campaign in Defense of the Cerrado and Consultation Protocols – Construction and Effectiveness, with the presence of Atix

## Socio-environmental Policy & Law

- Action in Brazil's National Congress and with the federal government to prevent the approval of a proposal aimed at allowing the indiscriminate opening of Indigenous Lands for third parties' activities (livestock, agriculture, forest management etc.), mitigating the exclusive right of use by the Indians, as well as to guarantee the right to free, previous and informed consultation.
- Support for the 9<sup>th</sup> Encontro e Feira dos Povos do Cerrado (Cerrado Peoples Meeting and Fair), in Brasília, in which ISA promoted a workshop to discuss with representatives of traditional Cerrado peoples and communities
- Participation in a public hearing in Brazil's National Congress with a delegation from the Xingu Indigenous Territory to present the consultation plan on the BR-242 highway and the Central-West Integration Railway (Fico, in the Portuguese acronym), which began to be implemented right away.

the experiences of communities in the elaboration and application of consultation protocols in their territories. The protocol is an instrument guaranteed by the International Labor Organization's Convention 169 and refers to free, previous and informed consultation.

- Work with the Conselho Nacional de Povos e Comunidades Tradicionais (National Council of Traditional Peoples and Communities, CNPCT) on the adequacy of the Cadastro Ambiental Rural (Rural Environmental Registry, CAR) in traditional collective territories and technical assistance to the Coordenação Nacional de Articulação das Comunidades Negras Rurais Quilombolas (National Coordination of Articulation of Black Rural Quilombola Communities, Conaq) for the definition of guidelines for the registration, analysis and validation of the quilombola CAR.

- **Participation in the Yanomami Leadership Forum, in Roraima, and in the discussions on indigenous rights that resulted in the elaboration of the Fora Garimpo (Mining Out) campaign, for the removal of the prospectors who invaded the Yanomami Indigenous Land, in Roraima.**



- **Second training module for indigenous communicators of the Negro River, in partnership with the Federation of Indigenous Organizations of Rio Negro (Foirn) and the Rio Negro Program.**
- Final phase of the Training Course on Climate Change and Political Incidence, in partnership with the Rede de Cooperação Alternativa (Network of Alternative Cooperation, RCA), and support for the Assembly of Indigenous Peoples during the Brazilian Conference on Climate Change, in Recife (Pernambuco).
- Support for the Acampamento Terra Livre (Free Land Camp, ATL) 2019, during the National Indigenous Mobilization, in articulation with other civil society organizations, especially in the area of communications and in the dissemination of the event, attended by more than 4,000 indigenous people.
- Expansion of the dissemination of *Copiô Parente*, a weekly podcast sent by ISA via Whatsapp to indigenous people and local partners from all over Brazil with news of interest to the peoples of the forest on the political agenda in Brasília. *Copiô Parente* reached more than 4,000 people in 2019, and in two years had 100 editions.



- During the 9<sup>th</sup> Yanomami Women's Meeting, six young Yanomami participated in training to build communication strategies based on Brazil's new Regulatory Framework for Civil Society Organizations. The action was a ISA-Hutukara Associação Yanomami partnership.
- In partnership with the Rio Negro Program and indigenous organizations from the Yanomami Indigenous Land, the second stage of the course on Brazil's new Regulatory Framework for Civil Society Organizations was held.
- Training for the advisers of indigenous peoples, traditional communities and family farmers to act in the meetings of the Sectorial Chamber of Holders of Traditional Knowledge of the Genetic Heritage Management Council (CGen).
- Work with the Associação dos Povos Indígenas do Brasil (Association of Indigenous Peoples of Brazil, Apib) to strengthen the legal collective, composed of indigenous lawyers and partner organizations, to assist the Mobilização Nacional Indígena (National Indigenous Mobilization, MNI). Work in the Joãozinho do Mangal Legal Collective, a National Coordination of Articulation of Black Rural Quilombola Communities (Conaq) body composed of *quilombola* and partner organizations.

### Monitoring of Protected Areas and Indigenous Peoples

- The website Povos Indígenas no Brasil (Indigenous Peoples in Brazil) published an entry on the Kujubim people, who live in southwestern Amazon, in the State of Rondônia, on the border with Bolivia. Considered extinct in the 2000s, the Kujubim are demanding the demarcation of their traditional territory and claiming their constitutional rights as indigenous people.



- **Participation in the 15<sup>th</sup> Terra Livre Camp (ATL) 2019 and in the 1st National March of Indigenous Women, two major mobilizations the indigenous movement held in Brasília. More than 4,000 people were at the ATL, and the march brought together approximately 2,500 women from more than 130 indigenous peoples. The team produced a map of indigenous women's organizations and conducted interviews with women from eight peoples of seven States, as well as photo and video records.**

### Ribeira River Valley

- Discussion of the implementation of the management resolution of native species in the State of São Paulo with the Consultative Council for the Environmental Protection Area of the Mid-Ribeira: monitoring and support to six workshops with the Quilombo Nhunguara Association, the Instituto de Terras do Estado de São Paulo (State of São Paulo Land Institute, Itesp) and Fundação Florestal, and meetings with the Quilombo São Pedro Association for the elaboration of Voluntary Management Agreements.
- Participation in the executive secretariat of the Council and follow-up of discussions on

the Management Plan for the Jacupiranga Conservation Units Mosaic (Mosac).

- Participation in meetings of the Fórum de Povos e Comunidades Tradicionais do Vale do Ribeira (Forum of Traditional Peoples and Communities of Ribeira River Valley), following the discussions on overlapping rights and conflicts with Conservation Units; support for the creation of the Forum's visual identity and to an act in defense of the demarcations of the Indigenous Lands of the Guarani ethnicities.
- Support for the National Coordination of Articulation of Black Rural Quilombola Communities (Conaq) State meeting in Quilombo de Ivaporunduva.
- Monitoring and articulation with parliamentary fronts (Traditional Peoples and Communities, Agrarian Reform/Land Regularization/ Food Security/Family Agriculture) in the State of São Paulo for the participation of traditional peoples and communities in them.
- Technical support to the Quilombo Ilhas Association, in Barra do Turvo (São Paulo), for the elaboration of its Rural Environmental Registry (CAR).
- Assistance in the participatory elaboration of proposals for local development projects of *quilombola* associations.
- Support for the Movimento dos Ameaçados por Barragens (Movement of People Threatened by Dams, Moab) in holding regional seminars to discuss current mining projects and alert the population to the risks.

## Negro River

- The Negro River's network of indigenous communicators was

selected – among 235 subscribers – to participate in an exchange program in TV Globo's *Profissão Repórter*, in São Paulo. The selection took place after a report on the São Gabriel da Cachoeira garbage dump was submitted. Cláudia Ferraz, a Wanano, and Moisés Luiz da Silva, a Baniwa, represented the group, training with the program team for one week.



- **The Yanomami and Ye'kwana's Territorial and Environmental Management Plan and its Consultation Protocol were handed over to the federal government in Brasília. Davi Kopenawa Yanomami, accompanied by directors of the main associations of the Yanomami Indigenous Land, in Amazonas and Roraima, toured 13 federal agencies handing over the documents. They did the same with government officials in Manaus (Amazonas).**
- Elaboration of cartographic material (tables, numerologies and thematic maps from georeferenced data) for discussion of Territorial and Environmental Management Plans (PGTAs, in the Portuguese acronym) by the coordinators of the Federation of Indigenous Organizations of Rio Negro (Foirn), as well as for the validation of the PGTAS of the nine Indigenous Lands and the PGTA Wasu, which covers Foirn's entire area of operation.

- In 2019, there were stages of validation of PGTAs in the Cué Cué Marabitanas and Balaio Indigenous Lands. The material gathered in the elaboration process was revised and exercises for mapping and prioritizing the proposals were carried out.
- Support for the participation of Waiwai leaders in the 48<sup>th</sup> Assembly of Indigenous Peoples of Roraima, promoted by the Indigenous Council of Roraima (CIR).
- With the advice of ISA, the 3<sup>rd</sup> Extraordinary Assembly of the Federation of Indigenous Organizations of Rio Negro (Foirn) was held to update its bylaws considering the requirements of the Civil Code and the Regulatory Framework of Civil Society Organizations, in addition to creating the new Socio-environmental Business department. Subsequently, the Board of Directors updated the institution's Internal Regulations.



- **To discuss threats such as mining in Indigenous Lands and the climate emergency, Foirn, with ISA's support, held a meeting with 256 indigenous youths from 15 ethnic groups in São Gabriel da Cachoeira (Amazonas) to reflect on the future.**
- ISA and Foirn renewed their Cooperation Term, effective

from 2019 to 2024, which aims to contribute to the economic, cultural and environmental development and the sustainability of the indigenous peoples of Negro River.

- **Event Turismo Indígena: Oportunidade para Fazer Amigos, Gerar Renda e Proteger o Território (Indigenous Tourism: An Opportunity to Make Friends, Generate Income and Protect the Territory)**, organized by ISA and Garupa, ISA's partner agency, at Unibes Cultural, in São Paulo. Five community leaders participated in the event to share experiences, discuss the relationship with travel agencies and tourist operators and tell how the community-based tourism activity is seen by their people.
- One hundred indigenous leaders from Foirn's five sub-regions began to elaborate the Rio Negro Indigenous Peoples Consultation Protocol, focused on the right to prior, free, informed and good faith consultation. The meeting, at the Foirn *maloca* (hut), was attended by the Associação Terra Indígena Xingu (Atix), which reported how the consultation protocol for the Xingu peoples was elaborated. The participants drew up a work plan for the elaboration of the protocol, with regional stages and a general stage of validation. They also drew up a public letter on Foirn's long work of representation in the region's indigenous movement.

## Communications & Relations

- The bleak scenario of fake news, incentive to deforestation, land grabbing, criminalization of NGOs, dismantling of environmental organs and of defense of indigenous rights which characterizes the current Brazilian government consolidated ISA as one of the most sought after sources by the national press and

International. Mainly reinforcing its positions in defense of indigenous rights and traditional communities, ISA sent the message: we shall resist alongside relatives and partners.

- **The #Povos da Floresta campaign was the largest and most complex production of the year, involving indigenous, quilombola and riverside dwellers' leaders, ISA's partners, in Presidente Figueiredo (Amazonas). Launched in April, during the celebrations of ISA's 25 years, the campaign *Vamos Continuar Resistindo* (We Shall Resist) reached 44,827 views in Portuguese and 21,959 in the English version.**

- *Fora Garimpo* (Mining Out), a campaign produced by ISA's Communications area, made the cover of the daily *Folha de S.Paulo*. The image brings the final message of the Yanomami and Ye'kwana leadership forum, held in November at the Yanomami Indigenous Land, in Roraima, against illegal mining – some 20,000 gold miners are in the region, threatening the lives of these peoples.
- Support and monitoring of the National Indigenous Mobilization, with ISA's Monitoring and Socio-environmental Policy & Law Program teams, held in April, in Brasília,

attended by more than 4,000 indigenous people from all over the country at the Terra Livre Camp.

- Joint work of ISA's Communications and Monitoring areas to support the edition of the documentary *Ka'azar Ukize Wà – Os Donos da Floresta em Perigo* (Ka'azar Ukize Wà – The Owners of the Forest in Danger). Images of isolated Awá-Guajá were captured by Guajajara filmmakers when filming their territory – both peoples share the Araribóia Indigenous Land, in Maranhão. The film was shown at the celebration of ISA's 25 years. In the occasion, the book *Cercos e Resistências: Povos Indígenas Isolados na Amazônia* (Sieges and Resistances: Isolated Indigenous Peoples in the Amazon), a portrait of isolated peoples – Brazil's most vulnerable –, was launched.
- The team participated and reported in a special article the celebration of the 10 years of the Yarang Women Movement – *yarang* are Ikpeng women gatherers –, which produces and gathers native seeds for the reforestation of springs and riparian forests of the Xingu River Basin around the Xingu Indigenous Territory (TIX), in Mato Grosso. It also participated and divulged the Meeting of the Xingu + Network, in the Kayapó's Menkragnetire Indigenous Land, which culminated with the manifesto *Uma Flecha do Xingu para o Mundo, pela #Amazônia* (An Arrow from the Xingu to the World, for #Amazonia).

### 3 Contribute to policies and initiatives for sustainable use of the forest, forest restoration and water resource management

#### Xingu

- Restoration of 156 hectares of degraded areas in the Xingu and Araguaia River basins, in 20 rural properties in Mato Grosso and Pará and in one Indigenous Land.
- Sale of 28 tons of seeds by the Associação Rede de Sementes do Xingu (Xingu Seed Network Association, ARSX) and 776 kilos by the Associação dos Moradores da Reserva Extrativista do Rio Iriri (Association of Residents of the Extractive Reserve of the Iriri River, Amoreri).
- Participation in the Latin America and Caribbean Climate Week, the 8<sup>th</sup> World Conference on Ecological Restoration and the International Union of Forest Research Organizations.



- **Support for the meeting that celebrated the 10 years of the Yarang Women Movement, in the Xingu Indigenous Territory (TIX).**
- Consolidation of the Caminhos da Semente (Seed Paths) initiative,

coordinated by Agroicone, with technical support by ISA and financial support from Partnerships for Forests (P4F). The initiative carries out planting, training, technical assistance and other activities.

- At the invitation of the Rainforest Foundation Norway and P4F, the Xingu Seed Network Association (ARSX) and ISA publicized in Norway and the United Kingdom the restoration work with native seeds through direct sowing.
- Technical support to TIX indigenous peoples in the production of honey, pepper and *pequi* oil.
- Technical assistance to the 14 *cantinas* (warehouses + community centers) and four mini-plants of the Terra do Meio Extractive Reserves, handling a record harvest of Brazil nuts and other socio-biodiversity products.

#### Socio-environmental Policy & Law

- Joint action with the coordination of the Environmentalist Parliamentary Front in the discussion of the Environmental Licensing Bill, the Provisional Measures of the Forest Code, the Proposed Constitutional Amendment (PEC) for Indigenous Agriculture, the Provisory Measures for the Political Reform of the Executive Branch, among other topics relevant to socio-environmental rights.
- Monitoring of public hearings, preparation of legal opinions and participation in national debates inside and outside Brazil's National Congress.

- **Institutional representation in meetings called by the Federal Prosecution Office and in public hearings in Brazil's National Congress in defense of social and environmental rights and policies.**

- Monitoring of the implementation of Public Call 02/2018 on Conversion of Environmental Fines – Restoration of flora populations threatened with extinction of the Atlantic Forest biome in the State of Santa Catarina.

### Monitoring of Protected Areas and Indigenous Peoples

- New website launched, gathering updated information on about 1,000 Federal and State Conservation Units (UCs, in the Portuguese acronym). The novelty is the inclusion of State UCs across Brazil. A highlight is the new dynamic panel of data and graphics (<https://uc.socioambiental.org/pt-br/paineldedados>), with information on management, extension, natural characteristics and thematic items such as deforestation and mining.
- Within the scope of Proteja, a partnership of ISA, Instituto de Pesquisa Ambiental da Amazônia (Amazon Environmental Research Institute, Ipam) and Instituto do Homem e Meio Ambiente da Amazônia (Institute of People and the Environment of the Amazon, Imazon), analyses and publications on protected areas were

produced, including assessment of management, implementation and threats to Conservation Units and Indigenous Lands. The analyses covered: the National Logistics Plan 2025 and protected areas in the Brazilian Amazon; management instruments in UCs in Legal Amazon; territorial consolidation of Indigenous Lands; trajectories of change in natural vegetation cover in the priority areas of the Project for the Conservation and Sustainable Use of Brazilian Biological Diversity (Probio); and mining in those areas.

- Subsidy to the Federal Prosecution Office with data on mining applications overlapping protected areas. In collaboration with the ISA's Socio-environmental Policy & Law area, maps and information on mining applications on Indigenous Lands and fully protected Conservation Units were produced for the Legal Amazon States of Pará, Acre, Maranhão, Mato Grosso, Rondônia, Roraima and Tocantins.
- Survey on industrial mining carried out by the team analyzed 170,000 mining processes across Brazil from the two information bases of the National Mining Agency (ANM, in the Portuguese acronym) – Geographic Information System and Mining (Sigmine) and Cadastro Mineiro (Mining Register). The information on Income Tax registration of the applicants for mining processes was cross-checked with the Federal Revenue Service base and an analysis was made of the incidence in protected areas and the potential for advancing processes regarding infrastructure (2025 scenarios).
- After surveying, systematization and analysis of qualitative and quantitative data on the legal and political context of Conservation Units' concessions to the private sector, an internal seminar was



held in May, in partnership with the Ribeira River Valley and the Socio-environmental Policy & Law programs, in order to build an institutional position on Conservation Units' concession policies.



- **Modeling of the socio-environmental impacts of infrastructure works in the Xingu River Basin. Construction of a database for computational modeling and simulation of scenarios for infrastructure in the basin, especially for the works of the Central-West Integration Railway (Fico) and the BR-242 highway. The work is part of a cooperation agreement of ISA and the Federal University of Minas Gerais (UFMG), and involved a socio-institutional diagnosis of the region of influence of the works and the construction of spatially explicit dynamic models for assessing economic efficiency and socio-environmental impacts.**
- In a collaborative effort with the Socio-environmental Policy & Law area, ISA supported the design and implementation of the Traditional Territories Platform, a joint initiative of the Federal Prosecution Office and the National Council of Traditional

Peoples and Communities with the aim of gathering and systematizing geo-referenced information on those territories, being them object of official recognition or not.

### Ribeira River Valley

- Participation in the Coordination Council of the Pact for the Restoration of the Atlantic Forest and the collective #MaisFlorestasPRASãoPaulo (#MoreForestsforSãoPaulo); monitoring of the São Paulo discussion on the Environmental Regularization Program (PRA, in the Portuguese acronym) and other instruments related to the implementation of the forest law.
- Contributions to discussions on the implementation of the State Secretary for the Environment's Resolution 189/2018, which establishes criteria and procedures for the sustainable exploitation of native species of Brazil in the State of São Paulo: debates with State agencies and researchers on the instruments and procedures necessary to make possible management permits to traditional peoples, such as the *quilombolas* of Ribeira River Valley.
- ISA took gatherers and technicians to participate in a course of forest seeds gathering and processing offered by São Paulo's Federal University of São Carlos (Sorocaba campus) and the Iniciativa Verde (Green Initiative), in the Cedro Nucleus of the Rio Turvo State Park, in the São Paulo municipality of Barra do Turvo.
- Support for the structuring of the Rede de Sementes do Vale do Ribeira (Ribeira River Valley Seed Network). In 2019, four *quilombola* territories (André Lopes, Nhunguara, Maria Rosa and Bombas) joined the network.

There are 25 gatherers and 94 species gathered, totaling 340 kilos sold for the restoration of 20 areas in the State of São Paulo.

- **1st Governance Meeting of the Ribeira River Valley Seed Network and course of forest seeds gathering, processing and storing at the Ouro Grosso Nucleus of the Alto Ribeira State Tourist Park (Petar), in Iporanga (São Paulo).**
- Elaboration of the architectural project for the Casa de Sementes (Seed House), in partnership with the Registro Federal Institute's technical course in Building, and adaptation of the structure of the Sítio Pedra Seedling Nursery, in Quilombo Nhunguara. A space to store forest seeds was also adapted in ISA's office in Eldorado (São Paulo).
- Presentation of the Ribeira River Valley Seed Network in events in Sorocaba and São Francisco Xavier (both in São Paulo), and to seedlings nurserymen of Barra do Turvo's Barra da Cruz/Rio Vermelho neighborhood.
- The network also participated in a demonstrative planting in Piracaia (São Paulo) together with the organization DaSerra Ambiental. A Field Day was promoted to show the muvuca (mixture of

native seeds planted with green manure) technique of planting at the University of the State of São Paulo (Unesp)'s Registro campus. Demonstrative plantings of the muvuca were also carried out in Cajati and Bofete (both in São Paulo).

## Rio Negro

- Participation in a round of formal negotiation and sale of 55 tons of raw nuts for the company Wickbold, within the scope of the Origens Brasil network.
- Participation of Waiwai extractivist leaders in the 1st Meeting of the Origens Brazil network, articulated by the Instituto de Manejo e Certificação Florestal e Agrícola (Forest and Agricultural Management and Certification Institute, Imaflo), with dozens of participants, bringing together companies, community associations and NGOs, among others.



- **Meeting of Waiwai and Wapichana extractivists from the Waiwai and Jacamin Indigenous Lands, articulated by ISA and the Roraima Indigenous Council (CIR), to exchange traditional knowledge and good practices in handling and managing the Brazil nut production.**

# 4 Contribute to reduce deforestation and environmental degradation, to increase sustainable sources in the energy matrix and to adapt to the impacts of climate change

## Xingu



- **Continuity of the Fire Management project, a partnership of ISA and the peoples of the Xingu Indigenous Territory (TIX) to face the climate crisis and fire management.**
- Publication of five Sirad X (acronym for Sistema de Indicação por Radar de Desmatamento, or Deforestation Radar Indication System) newsletters, production of 17 complaints and two technical notes that subsidized operations of the inspection bodies against deforestation in the Xingu Protected Areas Corridor.
- Consolidation of the threat and pressure comprehensive monitoring system on the Xingu Protected Areas Corridor through the operationalization of the Observatório De Olho no Xingu (An Eye on the Xingu Observatory), which is part of the Xingu + Network platform.
- Conduction of four surveillance expeditions of indigenous within the limits of the TIX.

- Participation in the Energy and Communities Fair and Symposium, in Manaus (Amazonas), which discussed alternatives for generating electricity in isolated locations in the Amazon.
- Participation in the International Wildland Fire Conference, Wild Fire 2019.
- Improvement of practices for managing planting fields without fire and for “forest regenerating” fields in TIX villages.

## Socio-environmental Policy & Law

- Participation in the mobilization of the civil society and production of memorials for the Supreme Court justices in the judgment of the Direct Action of Unconstitutionality (ADI, in the Portuguese acronym) 4717, which determined the unconstitutionality of the use of Provisional Measures by the Executive branch to reduce or disfranchise Areas of Permanent Preservation (APPs).
- Institutional representation in interinstitutional networks such as the Grupo de Trabalho sobre Infraestrutura (Infrastructure Task Force), Observatório do Clima (Climate Observatory), Observatório do Código Florestal (Forest Code Observatory), Rede de ONGs da Mata Atlântica (Atlantic Forest NGO Network) and Associação Brasileira de Organizações Não Governamentais (Brazilian Association of Non-Governmental Organizations, Abong), in addition

to assisting various civil society and social movements forums in analyses and strategies in the face of the current political situation in Brazil.

- **Energy and Communities Fair – Energy Solutions for Communities in the Amazon and launch of the film *Floresta Iluminada* (Illuminated Forest).**

### Monitoring of Protected Areas and Indigenous Peoples

- Development of a system for monitoring pressures and threats (deforestation, illegal logging and mining) for Indigenous Lands with reports of isolated peoples.
- Elaboration of scenarios of impact of deforestation and threats to protected areas in the Amazon, based on the historical trajectories of land use and land cover in the region. ISA's Geoservices team developed a routine to access and analyze deforestation data from the Deter-B system (of the National Institute for Space Research, Inpe, in the Portuguese acronym) to validate the monitoring and analysis of the impacts on the protected areas system in the Amazon.
- Collaboration with the Rede Amazônica de Informação Socioambiental Georreferenciada

(Amazon Georeferenced Social and Environmental Information Network, Raisg) in the research and systematization of information and data on mining activity and its impacts on Conservation Units in the Brazilian Amazon and its surroundings.

- Production of technical subsidies on public budget, deforestation and burning in protected areas, and elaboration of a scientific article (in collaboration with ISA's Socio-environmental Policy & Law area) for the first book in Portuguese on the subject of climate litigation (Joana Setzer; Kamyla Cunha; Amália Botter Fabbri. *Litigância Climática – Novas Fronteiras para o Direito Ambiental no Brasil*. São Paulo: Thomson Reuters – Climate Litigation – New Frontiers for Environmental Law in Brazil).
- Assessment of forest degradation in Indigenous Lands from illegal logging. In collaboration with the European Commission (Joint Research Centre), ISA developed a method to monitor areas impacted by selective logging in Indigenous Lands based on a combination of processing, classification and manual mapping of remote sensing data approaches. In 2019, the pilot initiative was applied on the Indigenous Lands of the states of Mato Grosso and Maranhão in a 15-year historical series.

### Amazon Georeferenced Social and Environmental Information Network (Raisg)

- **In partnership with MapBiomass Brasil, in March 2019 the Collection 1.0 of annual maps of coverage and land use from 2000 to 2017 for Pan-Amazon – the MapBiomass Amazônia – was launched. The complete database is available for download on the [www.amazonia.mapbiomas.org](http://www.amazonia.mapbiomas.org) platform, which includes an interactive map, in addition to**

**concise information and statistics. The information may be shown and summarized in different scales and units (Pan-Amazon, countries, States, municipalities, biomes, hydrographic basins, indigenous territories, protected areas). The platform also features several products available for download, including a concise infographic and a poster-sized map of Pan-Amazon Land Use and Coverage in 2017. The effort, under joint coordination of ISA, Fundación Amigos de la Naturaleza (FAN, Bolivia) and Instituto del Bien Común (IBC, Peru), involved the technical teams from Raisg's member organizations in Bolivia, Colombia, Ecuador, Peru and Venezuela, as well as cooperation with the Instituto de Pesquisa Ambiental da Amazônia (Amazon Environmental Research Institute, Ipam), which carried out the assessment of the Guyanas.**



- In partnership with the Coordenadoria das Organizações Indígenas da Bacia Amazônica (Coordination of Indigenous Organizations in the Amazon Basin, Coica), the Environmental Defense Fund (EDF) and the Woods Hole Research Center, the team investigated the loss of forest biomass in indigenous territories. A scientific article with the conclusions was written for publication, and a Special Raisg edition, to be published in 2020, was begun.

- All the cartographic databases in use were updated and consolidated. It is available for download on the network's website ([www.amazoniasocioambiental.org](http://www.amazoniasocioambiental.org)).
- New cartographic data on illegal mining, hydroelectric plants, oil and gas, mining, roads and fires was made available on Raisg's website. The data is available in the shapefile format.

### Negro River



- The Roraima Renewable Energy Forum, held in Boa Vista (Roraima), was attended by some 300 people. The forum is a permanent and consultative entity dedicated to debate, monitor and propose solutions around the theme energy in the State, and has 22 organizations in its composition. It was organized by the Euvaldo Lodi Institute (IEL) in partnership with ISA and the Instituto Clima e Sociedade (Institute Climate and Society, ICS).
- Monitoring and elaboration of cartographic material of the mining title applications to the Companhia de Pesquisa de Recursos Minerais (Mineral Resources Research Company, CPRM) that impact the territory in which the Federation of Indigenous Organizations of Rio Negro (Foirn) operates.
- Monitoring of deforestation and fires in the mid-Negro River region.

# 5 Increase society's support for the socio-environmental perspective

## Xingu

- The animation *Xingu, o Rio que Pulsa em Nós* (Xingu, the River that Pulsates in Us), which denounces the impacts of the Belo Monte Hydroelectric Plant and the Consensus Hydrograph in the Volta Grande do Xingu, in Pará, won an award at Anima Mundi, the largest animation festival in Latin America.



- Participation in the opening of the Climate Action Summit, a United Nations event in New York City.
- Elaboration of institutional editorials on the main events related to the socio-environmental agenda in conjunction with other ISA programs. Several interviews were given and journalists and communicators were advised when dealing with socio-environmental issues.

## Monitoring of Protected Areas and Indigenous Peoples

- Aiming to support the transparency of public, governmental and civil society data, the team developed a strategy to safeguard such data as a contribution to the right to access information, guaranteed by the Universal Declaration of Human Rights, the International Covenant for Civil and Political Rights and the American Convention on Human Rights (San José Pact), all ratified by Brazil. In this process, more than 15,000 domains were identified.

- Production of the animated film *#ConsultaXingu - Indígenas Lutam por seu Direito a Voz* (*#ConsultXingu - Indigenous People Fight for their Right to a Voice*), shown at a public hearing in Brazil's National Congress.

## Socio-environmental Policy & Law

- Editing of the book *Subvertendo a Gramática e Outras Crônicas Socioambientais* (Subverting Grammar and other Socio-environmental Chronicles), written by ISA's founding partner Márcio Santilli.





- ISA participated in the Proteja Talk, an initiative in the format of TED Talks or TEDx (short testimonials to present a story), in which it shared socio-environmental narratives about Territories of Diversity via the protagonism of partners, within the scope of the ISA, Instituto de Pesquisa Ambiental da Amazônia (Amazon Environmental Research Institute, Ipam) and Instituto do Homem e Meio Ambiente da Amazônia (Institute of People and the Environment of the Amazon, Imazon) partnership. Ten indigenous and extractivist leaders, communicators and professionals linked to socio-environmental issues presented their trajectories and challenges. The meeting was recorded and converted into content for the site <http://proteja.org>. (<https://www.socioambiental.org/pt-br/blog/blog-do-monitoramento/proteger-um-sonho-possivel>)

**Amazon Network of Georeferenced Social and Environmental Information (Raisg)**



- **Amazônia na Encruzilhada (Amazon at the Crossroads)**, the second special feature prepared by Raisg in partnership with Rede Infoamazônia, presented the impacts of infrastructure works, fires and deforestation on protected areas and indigenous territories in

**Pan-Amazon. It had great national and international repercussion, with the publication of 54 pieces of news in 13 countries, thus contributing to disseminate the data Raisg produced. The document discusses the conflict between the vision of economic development and the rights of indigenous territories and the conservation of protected areas in six countries and can be accessed at: <https://encruzilhada.amazoniasocioambiental.org/>**

- With uncontrolled fires impacting the Amazon, Raisg was highly requested by the national and international media to reverberate the theme not only with interviews: it provided the BBC UK network with systematized data about the different regions of the Pan-Amazon.

**Ribeira River Valley**

- Special article and video documentary *Trabalha Junto, Festeja Junto* (Work Together, Celebrate Together), produced by the Communications and Ribeira River Valley teams in partnership with Cooperquival (Quilombolas Farmers' Cooperative in the Ribeira River Valley) and *quilombola* associations with support from the European Union. They feature the corn harvest in Quilombo São Pedro and the party that follows it, reinforcing the importance of the Quilombola Traditional Agricultural System, which was recognized as a Brazilian cultural heritage in 2018.

- **At the launch of the #PovosdaFloresta (#ForestPeoples) campaign at SESC Registro, with the participation of caiçaras (traditional inhabitants of the coastal regions of the Southeast and South Brazil), caboclos (Brazilians with Indian and European ancestry) and quilombolas, as well as anthropologist Mauro Almeida,**

## ISA organized the conversation circle "Paths to Resolve Overlapping Conflicts between Traditional Territories and Conservation Units in the Ribeira River Valley".

### Negro River

- In a Leadership Forum held in the Yanomami Indigenous Land's Watoriki village, in Roraima, the Yanomami and Ye'kwana peoples together denounced the invasion of 20,000 gold miners, reported serious impacts of mineral extraction on their lands and asked the government to comply with the law and protect their territory. In a letter addressed to the top authorities of the Executive and Judiciary branches, they describe the various impacts of the presence of the miners and of mining activity in their land and demand: *Fora Garimpo* (Mining Out).

### Communications & Relations

- The team produced and disseminated 358 pieces of news and special reports in the national and international media. The highlight was the repercussion of the outburst of fires in the Amazon in August. A reference on the topic, ISA was much requested by the press, and Adriana Ramos, from ISA's Socio-environmental Policy & Law area, gave more than 20 interviews on the subject in one week to national and

foreign radio and TV stations, such as the BBC and Rede Globo's *Jornal Nacional*, Brazil's most watched daily news program.

- In July 2019, the Mostra ISA 25 Anos (ISA 25 Years Film Festival), in celebration of ISA's 25<sup>th</sup> anniversary, screened at Unibes Cultural, in São Paulo, films made in recent years about indigenous peoples and by indigenous filmmakers. Eight films produced by ISA and its partners were screened. Two of them were unreleased – one on Ikpeng women (seed collectors in the Xingu Indigenous Territory), one on isolated groups in the Araribóia Indigenous Land, in Maranhão. The other films denounced the risks and threats to indigenous peoples and traditional communities in Brazil, showing their resistance as well.



- ISA's 25<sup>th</sup> anniversary celebrations ended with the launch of the book *Cercos e Resistências: Povos Indígenas Isolados na Amazônia* (Sieges and Resistances: Isolated Indigenous Peoples in the Amazon) and the screening of the film *Ka'azar Ukize Wà – Os Donos da Floresta em Perigo* (Ka'azar Ukize Wà – The Owners of the Forest in Danger), with images of isolated Awá-Guajá captured by Guajajara filmmakers – the Guajajara and the Awá-Guajá share the Araribóia Indigenous Land, in Maranhão.



- The publication *ISA 25 Anos Unidos pela Diversidade* (ISA 25 Years Together for Diversity) was also launched. It tells ISA's trajectory and of its historical partners in this quarter of century in defense of indigenous rights, of *quilombolas* and traditional peoples, and of the environment.
- In social networks ISA's growth was expressive. On Twitter, the number of followers increased threefold compared to 2018. On Instagram, the number also tripled over the previous year. The increase is directly related to the greater presence of ISA in networks with growing numbers of posts (see more on page 46, *ISA in numbers*).

## Documentation

- During the year, the Socioambiental Collection Platform (<https://acervo.socioambiental.org/>) had 144,593 user sessions (**a 268.42% growth compared to 2018**) and 279,268 page views (**a 103.47% growth compared to 2018**) and reached more than **211 mil items**:
- 182,724 articles/pieces of news;
- 19,827 documents;
- 5,065 photos;
- 2,746 books;
- 395 dissertations/theses;
- 245 publications by ISA;
- 250 videos;
- 59 maps.



## 6 Strengthen ISA's institutional capacity

### Xingu

- Support to the participation of four collaborators in national and international events and in professional training.
- Xingu Strategic Management Council in full operation, established as the program's highest decision-making body.
- Team's strategic reflection process, carried out with ISA's Strategic Management Council as a basis for planning the next five-year plan.

### Socio-environmental Policy & Law

- Participation in legal proceedings in defense of the ISA.
- Active participation in internal task forces, including all ISA programs on gender, holistic security and institutional security.
- A policy aimed at protecting children and adolescents is in the process of being drawn up.
- The process of moving to new headquarters in Brasilia, with larger spaces for events and greater interaction with the public, has started.

### Monitoring of Protected Areas and Indigenous Peoples

- Creation of the Monitoring Strategic Management Council, established as the program's highest decision-making body, building integrated planning frameworks together with the Amazon Network

of Georeferenced Social and Environmental Information (Raisg) and ISA's Geoservices area.

- Technical Cooperation Agreement signed between ISA and the Federal University of Minas Gerais (UFMG)'s Centro de Inteligência Territorial (Center for Territorial Intelligence) to implement actions aimed at environmental analysis and to develop predictive models of deforestation and impacts of infrastructure works and public policies.

### Amazon Network of Georeferenced Social and Environmental Information (Raisg)

- The training of the technical team on the Google Engine platform within the MapBiomias Amazônia project definitely raised the network's analytical capacity, not only within the scope of the project, but also to work with new relevant topics such as fire and fire scars.
- Organization of the network's annual meeting for strategic planning and evaluation in São Paulo, with the participation of all member organizations: FAN (Bolivia), Imazon and ISA (Brazil), Gaia (Colombia), EcoCiencia (Ecuador), IBC (Peru), Provita and Wataniba (Venezuela).

### Ribeira River Valley

- First stage of elaboration of the strategic plan for the Ribeira River Valley Program (2020-2025).
- **Discussion of the expansion of ISA's actions in the quilombola national agenda with the National**



**Coordination of Articulation of the Black Rural Quilombola Communities (Conaq), in a round table held with representatives of Conaq and the communities of the Ribeira River Valley.**

### Negro River

- Implementation of three medium-term projects: Strengthen the Sustainable Management of Indigenous and Traditional Territories to Ensure Rights, Fight Deforestation and Promote the Sustainable Use of Forests, supported by the Rainforest Foundation Norway; Management and Governance of Indigenous Lands in the Negro and Xingu River Basins, supported by the Amazon Fund; Strengthening Socio-biodiversity Value Chains in the Territories of Diversity, supported by the European Union.
- Update of the Negro River Program Strategic Plan, prepared in 2015, for 2016-2020.

### Communications & Relations

- In 2019, the number of ISA affiliates increased by 82% over the previous year (442) to almost 900. The goal is to reach 1,000 members in 2020. Donations have also grown by 65%.



- The team organized two events at the Pinheiros Municipal Market, in São Paulo, for the valorization of forest products. In the first, in August, three cooks, winners of a contest promoted by the municipality of Vitória do Xingu (Pará), presented their winning recipes. In December, the Festival pelos Povos da Floresta (Festival for the Peoples of the Forest), organized by ISA and the Origens Brasil® chain with support from the European Union, brought products from the communities the Ribeira River Valley, in São Paulo, the Xingu, in Mato Grosso and Pará, and the Negro River, in Amazonas and Roraima, which for years have faced the challenge of building a positive relationship with the market to sell their production of nuts, flours, spices, oils, honey and other items. During the event, a chocolate made with cocoa from the Yanomami people was launched in partnership with chocolatier De Mendes.

- There were 1,249 insertions from ISA in newspapers, websites, radio and TV. Of these, 42 were radio and TV interviews. Eleven signed articles were published in newspapers and websites such as *El País*, *Correio Braziliense*, *Folha de S. Paulo*, *Le Monde Diplomatique*, *Eco*, *Valor Econômico* and *Frankfurter Allgemeine*.

- Created in the end of 2017, the Gender Task Force is made up of representatives from all ISA areas and programs. In 2018, a gender policy for ISA was implemented. In parallel, a hosting instance was created, independent of the task force. It is a space for listening and mediation in cases of embarrassment or harassment. In 2019, the task force worked on the second version of an orientation guide for coexistence agreements with local communities regarding gender.

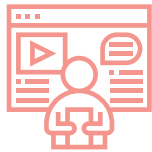
